FCSC Annual Meeting

The Annual Meeting of the Funeral Consumer Society of Colorado was held on May 2, 2015 at the First Universalist Church of Denver, with close to 50 people in attendance. The meeting was called to order by Jan Eccher, President. Jan spoke about our activities this year:

- Three Colorado bills related to our interests came up this year. HB 1135, which is similar to Oregon's doctor assisted suicide bill, was defeated. HB 125 concerning a statewide registry of advance directives was postponed indefinitely. HB 110, which extends the Mortuary Science Code regulations for funeral homes and crematories until June 2024, was passed. It was introduced in October of 2014 and went into effect July 1, 2015.
- Member totals are 3,215, which is a decrease of 55 from the 3270 members of a year ago. The number of Life Members has decreased due to deaths or moves out of state.
- Jan presented our net worth and largest expenses. The biggest expense is the postage for the Newsletter, followed by dues to Funeral Consumers Alliance, our parent organization, and then our rental fee and liability insurance payments for use of the First Universalist Church.
- Jan announced our inheritance of over \$100,000 from a member's estate; she explained that this was an unexpected, but deeply appreciated, surprise for us. She then asked those present for ideas of how we might best use this windfall for our mission of education. Suggestions included:

- *Have a booth at the Senior Colorado Law Days
- *Become a participant in Bemis Library's information on aging
- *Have a booth at resource fairs, such as Buck Rec Center and Malley Sr. Rec
- *Be a sponsor for Colorado Public Radio ("CPR")
- *Make videos for possible showing on YouTube and Facebook
- *Place an ad in the obituaries section of newspapers
- *Arrange for feature articles on FCSC in newspapers

SPEAKERS

Jan then announced our speakers: Jim and Judy Taylor with our website presentation, Anita Larson of the Colorado Death Café, and Stewart Fleisher, estate attorney.

Using a media presentation with a large screen, Judy and Jim walked the audience through our website. This site was initiated last summer and is frequently updated to keep users aware of current news. Options on each page, which were briefly discussed, are: "Home", "Membership", "Contract Providers", "Resources", "Newsletters", "News", "Annual Meeting Speakers", "About Us", and "FAQ".

Anita Larson is a professional Family Celebrant who helps organize funerals and memorials. Anita has been interviewed by Colorado Public Radio, and the Denver Death Café has been featured in Westword, The Best of Denver and in the Intermountain Jewish News. She, with assistance from Greg Whitehair, opened the first Denver Death Café in September, 2013. The Death Café is a global, life-confirming movement started in England in 2011, and it now has 1,774 world-wide cafes. Death Café operates as an open, self-generated dialogue which discusses death, dying and end-of-life concerns. It is not a grief or counseling group. The Denver chapter, which

meets at Porter Place, 1001 E. Yale Avenue, Denver at 3:00 pm on the third Sunday of each month, is free, open to all and includes refreshments. Information is available on Facebook, Pinterest and their website www.deathcafe.com.

Stewart Fleisher, long-time past FCSC Board Member, spent the majority of his address on the subject of probate - why it exists, who opens probate and how it can be avoided. Probate is a court proceeding in which it is assured that any creditors are paid before estate assets are distributed. It can be opened by an executor or an attorney representing the executor. If an executor decides not to open probate, he or she is liable for paying all debts, including outstanding bills, credit card charges and a mortgage. Stewart named other tasks that can be done ahead of time which can help avoid probate. He also made note of many other important items about Death Certificates, assets and release of funds, Small Estate Affidavits, Federal estate taxes, state taxes, the "Step-up in Basis", challenged wills, and gift allowances without taxes.

A brief Board business meeting followed the Annual Meeting. The Board Meeting schedule for the 2015/16 year is July, September, October, January, February, March, April and the Annual Meeting in May.

Jan attended some sessions of the Funeral Consumer Alliance Board meeting held in Denver over the April 25th weekend. She gave highlights of that meeting.

Subjects discussed by Board members at the business meeting were:

- Memberships of folks taking advantage of the reduced fees of our contract providers (vote was made to require at least 1 year of membership for this)
- Looking into what to do if someone dies out of state or out of country
- Whether we should look into participating in the Colorado Law Day

Other Board Meeting News

We remind everyone that they are welcome to attend any of our Board meetings. These are generally held at 10:00 AM on the fourth Thursday of the month. We meet at the First Universalist Church, at 4101 E. Hampden Ave. in Denver.

Grant Steffen, our Outreach person, had a ½ hour interview about FCSC with Channel 4; other news must have prevailed, because it was not aired. Grant also had a talk scheduled with Denver Hospice which was cancelled. He will be speaking at Buck Recreation Center on Oct. 22. Grant and Larry Clarke are working together to create videos of interviews with Board members for the website.
